By signing this agreement, I acknowledge that I have read the Glass Gallery Rules, Regulations and Information document and agree to abide by the rules and regulations set forth in the document. I understand that the Glass Gallery reserves the right to remove any non-complying items or close, without refund, any participant's booth not conforming to these rules and regulations. Any disagreements regarding the rules and regulations, or between participants, will be settled by the Glass Gallery Co-Chairs, and I agree to abide by that decision.

The Glass Gallery will not be held liable for failure of the event to take place. Furthermore, I release the Pacific Northwest Glass Guild (PNWGG), its officers, sponsors and agents from responsibility in case of loss or damage to all or part of my exhibit or my person.

I understand that a 20% commission fee on gross sales is due at the close of the show. The commission will be reduced if I complete a pre-arranged work assignment before, during or after the show: 4 volunteer hours pays 12%; chairs, coordinators and other jobs that require more than 4 hours pays 8%. **I am responsible for arranging my work assignment with the Volunteer Chair no later than April 10th or be subject to the 20% commission fee. I agree with this fee schedule and will pay the fee in full at close of the show.**

I certify that the work in my booth is produced substantially by me. By signing this agreement, I grant PNWGG permission to use, for publication with attribution, any photos submitted in conjunction with this show.
